<p>Update on Proposed Walking Trail:</p> <ol style="list-style-type: none"> 1. Beginning to work on Recreation Plan. Could take up to 1 year to complete. 2. Trustee Hall attended a conference on trails 3. Cost is approximately \$200-230,000.00 per mile 4. Kelly Bekken recommends using the Railroad ROW from Lake City Christian Reformed Church to Pavilion 5. Trail owners at the conference said they have had minimal security issues. 6. Klaus Heinert from Gosling Czubak arrived and presented the board with a proposed plan for the trail. 7.
