<p>Public Comments: Commissioner Susan Rogers informed the Board that the census committee had a redistricting formula figured out for Missaukee County. Lake Township had the most growth in the county according to the recent census with Caldwell Township having the second most growth. The first redistricting had only Lake Township with a split commissioner district. However, a final decision has not yet been made. If the current redistricting map is finalized, there will be five split districts in the county. County is negotiating three union contracts and working on next year’s budget. Duddles reported that insurance costs were \$4887.00 and \$7,500.00 was budgeted. There is presently about \$9,000.00 in unpaid fire runs.
